# AMENDMENT TO STAFF REPORT & DECISION SHORELINE EXEMPTION— TYPE I 005/17 SHE — SUNLIGHT SHORE COUNTRY CLUB REMOVE EXISTING BULKHEAD & CONSTRUCT SOFT SHORE PROTECTION

### I - AMENDMENT

The approval for the Shoreline Exemption 005/17 SHE is hereby amended to authorize a proposed 30ft long partially buried rock revetment that will run perpendicular to the shoreline just south of the northern property line that will be adjacent to the wood bulkhead of the neighboring property to the north. The original proposal that was approved included pinning salvaged wood with large boulders along the northern property line, however, following further evaluation of the neighboring bulkhead which is in poor condition, this partially buried rock revetment is a preferred design for this location. The rock revetment will be constructed of approximately 40 cubic yards of existing on-site material salvaged from the existing beach rockery.

This amendment does not modify any findings or Conditions of Approval contained within 005/17 SHE. Any further modifications may require a new shoreline permit.

# II - APPEALS

To file a written statement of appeal to the hearing examiner, the written statement of appeal must be received within fourteen (14) days following the mailing of the director's decision by either personally delivering the written statement of appeal to the office of the director that issued the decision, or by mailing the written statement of appeal to the following address: Island County Hearing Examiner, P.O. 




